

## NOTICE OF ELECTION

### TO THE QUALIFIED ELECTORS OF THE CITY OF KENDLETON, TEXAS AND ALL OTHER INTERESTED PERSONS:

The City of Kendleton (the "City") will hold a Sales and Use Tax Election (the "Election") jointly with Fort Bend County on Saturday, May 7, 2016 between the hours of 7:00 a.m. and 7:00 p.m., at Precinct No. 1002, Kendleton Church of God, 619 FM 2919, Kendleton, Texas 77451.

The proposition to be voted on in the Election is as follows:

#### PROPOSITION NO. 1

THE ADOPTION OF A SALES AND USE TAX WITHIN THE CITY OF KENDLETON AT THE RATE OF ONE-HALF OF ONE PERCENT, TO PROMOTE OR DEVELOP PROJECTS DEFINED UNDER SECTION 2 AND SECTION 4B OF ARTICLE 5190.6, VERNON'S TEXAS CIVIL STATUTES, INCLUDING, BUT NOT LIMITED TO PROJECTS FOR PROMOTION OF PROFESSIONAL AND AMATEUR (INCLUDING CHILDREN) SPORTS, ATHLETIC, ENTERTAINMENT, TOURIST, CONVENTION, AND PUBLIC PARK PURPOSES AND EVENTS, INCLUDING, BALL PARKS, PARKS AND PARK FACILITIES, OPEN SPACE IMPROVEMENTS, CITY BUILDINGS, MUSEUM EXHIBITION FACILITIES, RELATED ROADS, STREETS, AND WATER AND SEWER FACILITIES, AND OTHER RELATED IMPROVEMENTS THAT ENHANCE ANY OF THESE ITEMS; TO PROMOTE OR DEVELOP NEW OR EXPANDED BUSINESS ENTERPRISES, INCLUDING PUBLIC SAFETY FACILITIES, STREETS AND ROADS, DRAINAGE AND RELATED IMPROVEMENTS, DEMOLITION OF EXISTING STRUCTURES, GENERAL CITY OWNED IMPROVEMENTS, AFFORDABLE HOUSING, AND IMPROVEMENTS OR FACILITIES THAT ARE RELATED TO ANY OF THESE PROJECTS; AND OPERATING AND MAINTENANCE COSTS OF THE CITY OWNED PROJECTS. THIS ADOPTION WOULD INCREASE THE ADDITIONAL SALES AND USE TAX FROM ONE HALF OF ONE PERCENT TO ONE PERCENT
