Council Jenkins: YMCA – Meeting for youth will be held at the Swing Door Restaurant in Richmond, Texas. Looking at opening this year at the Powell Point School – Last two years there has not been a program in place – I will be attending this meeting to make sure that the Kendleton children are included. There will be an annual fee that they are requesting from all cities to support this program.

Council Goodjoint asked if this program was at the Kendleton Church of God at one time. Council Jenkins replied, yes.

Council Jenkins stated that they inquired about the building Rev. Booker has up to have the program but felt that it would be better to have at the school.

I attend the Fort Bend County Mayor and Council Association Meeting on January 26, 2017 in Missouri City, guest Glen Whitehead presentation on drones: They talked about drones that will be used to for surveying and engineering measurement technology. Drones will be a perfect platform for aerial photography and remote sensing etc.

Council Goodjoint asked if there was any way to stop the horses that are walking through citizen property on HB Collins. Council Aldridge stated that he would talk with one of the citizen "Bubble" concerning the horses getting loose and walking over citizen property.

Council Phillips informed the councils that she had attended the meeting with the Planning Committee and attending the meeting was Mr. & Ms. Smith on Pink Taylor Run road. They were concerning about their property staying as agriculture property through the new zoning. Council Aldridge ask Council Phillips did she explain to them that we will not be changing property that is in agriculture status. Council Phillips stated, yes. Planning and Zoning is concern about why they have not received a map that has been requested for some time now.
